# MISSION AGREEMENT TERMS & CONDITIONS RESPONSIBILITY & LIABILITY

The responsibility of CLI TRAVEL, Inc, (CLI), its associated organizations and representatives, is strictly limited. CLI TRAVEL, INC. as a tour operator, organizes, promotes, and sells Tours and Humanitarian Missions consisting of travel services that we purchase or reserve from various suppliers, including but not limited to, surface transportation, excursions and accommodations. To the extent that CLI Travel, Inc. is involved in the sale of air transportation to you, we act as an agent of the air carrier. The suppliers and independent contractors are NOT agents or employees of CLI Travel, Inc.

### 1. WILLFUL OR NEGLIGENT ACTS

Neither CLI TRAVEL, nor its representatives are responsible for the willful or negligent acts and/or omissions of such suppliers or of any air carrier or their representatives, employees, agents, servants or representatives including, without limitation, their failure to deliver or their partial or inadequate delivery of services. All coupons, receipts, reservations, and tickets are issued subject to the terms and conditions specified by the suppliers/and or air carriers.

### 2. NATURE OF MISSIONS AND ACKNOWLEDGEMENT OF RISK

Travel in developing nations is far different from travel in the United States. Tours in Vietnam, Laos, Cambodia or Southwest China, like other forms of travel, can involve inconvenience and risk, including forces of nature, geographic and climactic conditions, hygienic standards, infrastructure problems (such as road maintenance, transportation delays and accommodation conditions), civil unrest or terrorism. Medical services or facilities may not be readily available during all or part of a tour and, to the extent they are available, may not equal American or Western standards.

### 3. TRAVELER/DELEGATE RESPONSIBILITY

Participants are solely responsible for being in sufficient health to undertake the mission and for taking all appropriate medical precautions. CLI recommends that you obtain medical, trip & cancellation insurance. Preparation for the tour should include studying the itinerary and pre-departure information provided by CLI and its associated organizations.

CLI reserves the right to remove any traveler who engages in such illegal activities from the tour and to return such individual to his or her point of departure at their own expense.

**PARTICIPANTS ARE SOLELY RESPONSIBLE FOR THEIR OWN WELFARE AND ACCEPT ANY AND ALL RISKS OF DELAY, UNANTICIPATED EVENTS, ILLNESS, INJURY, EMOTIONAL TRAUMA, DEATH OR ANY COST INCURRED DUE TO INCORRECT OR MISSING INFORMATION PROVIDED TO CLI BY THE TRAVELER OR BY HIS OR HER BOOKING AGENT.**

#### 4. SERVICES PROVIDER RESPONSIBILITY

Travel services are provided by various suppliers who are independent contractors, and are not agents or employees of CLI. By using these services, **PARTICIPANT SPECIFICALLY AND WITHOUT RESERVATION AGREES THAT NIETHER CLI NOR ITS REPRESENTATIVES WILL BE LIBALE FOR ANY HARM TO PARTICIPANT ARISING FROM OCCURENCES OR CONDITIONS BEYOND CLI'S CONTROL, INCLUDING ANY PHYSICAL, EMOTIONAL, INDIRECT OR CONSEQUENTIAL HARM.**

#### 5. RESERVATION OF RIGHTS

*CLI reserves the right to reprice, cancel, or withdraw any mission, tour, trip or excursion or expedition for any reason, to alter or omit any part of the itinerary, and to substitute tour leaders, agents and accommodations. CLI will not assume responsibility for participant expense incurred in preparing for the trip (such as non-refundable advance purchase air tickets, equipment, communication costs, obtaining medical services, making changes in the tour, or other matters of a personal nature.*

CLI reserves the right to decline, accept or to retain any persons as a member of any tour. CLI further reserves the right to take photographic or film records of any participants, mission or tour and to use such records for promotional and/or commercial purposes.

#### 6. RELEASE AND DISCHARGE

The costs of the tours offered by CLI are based upon the execution of this **MISSION DELEGATE AGREEMENT** by all participants. **DELEGATE UNDERSTANDS AND ACCEPTS THE TERMS AND CONDITIONS STATED IN THIS AGREEMENT, AND RELEASES AND DISCHARGES CLI AND ITS REPRESENTATIVES FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM PARTICIPATION ON THE MISSION.** Any parent or guardian of a participant who is a legal minor must accept this agreement on behalf of the minor.
